AB/091.18 Chairman's Update

The Chairman welcomed members and the public to the meeting. He and Miss Quine had held what he considered to be a positive meeting with the acting director of transport to discuss issues in the town.

AB/092.18 Approval of minutes from Ordinary Board Meeting

Mr Ludford-Brooks proposed that the minutes of the Ordinary Board Meeting dated 7th Jan 2019 be approved as read. This was seconded by Mr McAleer with all in favour. The minutes were duly approved.

A letter was received from Manx Blind Welfare regarding their intention to hold a collection in Shoprite on 15th June 2019. The correspondence was duly noted.

A letter was received from Pauline Stewart of Castletown Heritage enclosing a donation of £100 for use of the Community Hall. Members asked the Clerk to thank

the organisation and suggested that the donation be ringfenced to improve the provision of computers in the library.

A letter was received from Mrs Thompson of the Manx Ornithological society regarding the plight of swifts visiting Manx shores. Members requested that the Clerk assist the society in their desire to site nesting boxed in the town.

A letter was received from the Manx Agricultural Marketing Society Ltd requesting that the Commissioners impose restrictions on any mobile traders that a licence would only be granted if they could demonstrate the Manx Provenance of specific products.

Whilst supporting the concept, members did not believe that there was any way that guarantees could be made, and no proposals were brought forward. The matter was duly noted.

A letter was received from Minister Boot regarding the launch of the "refill" scheme on the Isle of Man. The letter was noted with Mr Leather commenting that he was delighted that the government was following the example of the Town who had been members of the scheme since the refurbishment of the Victorian Drinking Fountain last summer.
