

Manifesto

Increase and maintain existing social housing

Castletown faces a critical housing shortage. Too many residents endure inadequate living conditions while waiting for Commissioner housing, and the lack of affordable options is pushing families into poverty and straining our community. The Castletown Commissioners must prioritize securing funding to upgrade and expand the town's social housing stock.





Reform Planning Procedure

The planning process needs reform to prioritise our community needs over developer interests. We must shift the focus to protecting our environment, preserving affordability, and enhancing our community. Residents deserve a stronger voice in shaping the future of Castletown and should have greater influence over local development.

Increase facilities and access for the young, old and those with disabilities

Castletown's residents deserve more opportunities and we are a diverse community. We must address the lack of facilities for adolescents by leveraging existing resources and collaborating with local groups, sports clubs, and charities. Making spaces like the civic centre and the square more accessible to community activities and youth organisations is a key step in providing people of all backgrounds with an inclusive, engaging and enriching experience.

Rebuild Southern Civic Amenity Site

The Southern Civic Amenity Site is no longer adequate. Given the recent growth of new housing developments in the south, the population center has shifted significantly, likely closer to Ballasalla than Port St Mary. This shift justifies exploring the feasibility of relocating the amenity site to a more central location, such as near Castletown, to better serve the current population.




Utilities reduction/concession for Town Homes & Businesses

Extortionate utilities payments are squeezing working and middle-class families and small businesses in Castletown, harming our community. To address this issue and ensure a more equitable housing and business environment, we should explore potential concession agreements and improve those in place such as Time-of-Use Tariffs, Dynamic Pricing, Demand Response Programs and Energy Efficiency Obligations.

Absent voter's ballot

Absent voter's ballot papers can be obtained only by means of an application duly completed and received by the Town Clerk of Castletown Town Commissioners.

a) where the absent voter's ballot paper is to be marked in the Isle of Man, at least 7 clear days before the day fixed for the poll.

b) where the absent voter's ballot paper is to be marked elsewhere than in the Isle of Man, at least 9 clear days before the day fixed for the poll.

Absent voter's ballot papers will be issued to persons whom the returning officer has accepted as being entitled to vote as such at the address in the Isle of Man or elsewhere as notified to the returning officer.

a) where the absent voter's ballot paper is to be marked in the Isle of Man, at least 5 clear days before day fixed for the poll.

b) where the absent voter's ballot paper is to be marked elsewhere than in the Isle of Man, at least 7 clear days before day fixed for the poll.

Provided that where the absent voter's ballot paper is to be marked in the Isle of Man the ballot paper may be delivered to the absent voter at any time before the close of the poll.
